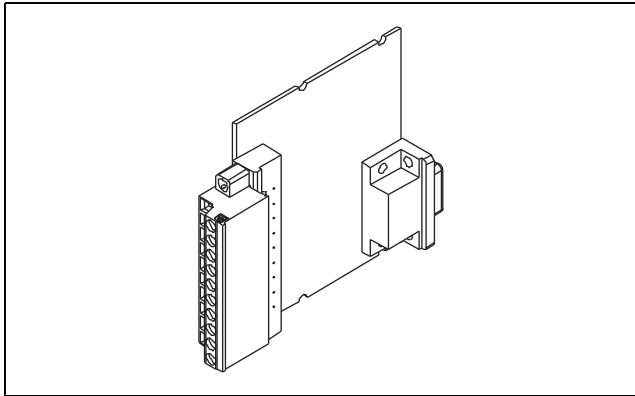


# OPERATING INSTRUCTIONS AND SPECIFICATIONS

## NI 9263E

4-Channel,  $\pm 10$  V, 16-Bit Analog Voltage Output Module



This document describes how to use the National Instruments 9263E and includes dimensions, terminal assignments, and specifications for the NI 9263E. 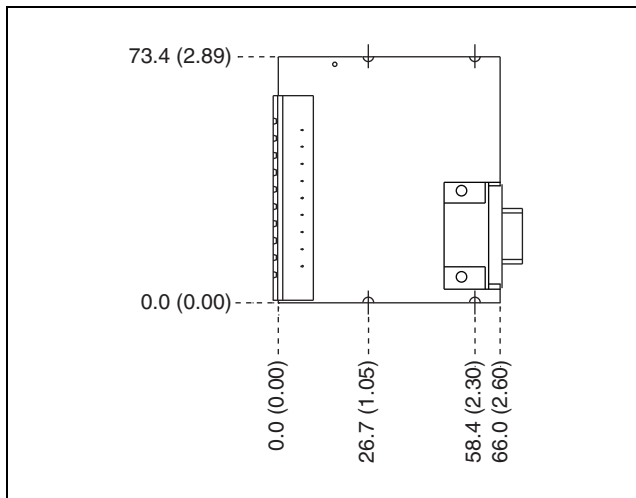

# NI 9263E Dimensions

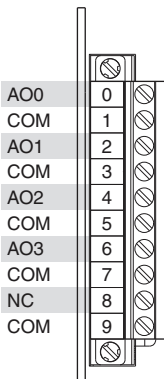
The following figure shows the dimensions of the NI 9263E.



**Figure 1.** NI 9263E Dimensions in Millimeters (Inches)

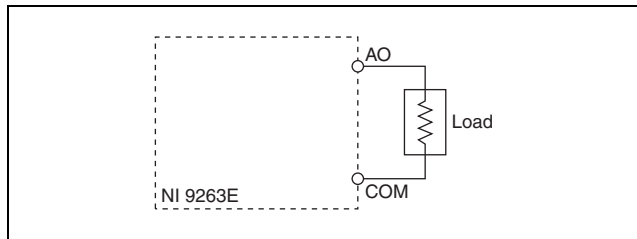
## Connecting the NI 9263E

The NI 9263E has a 10-terminal, detachable, screw-terminal connector that provides connections for 4 analog output channels.



**Figure 2.** NI 9263E Terminal Assignments

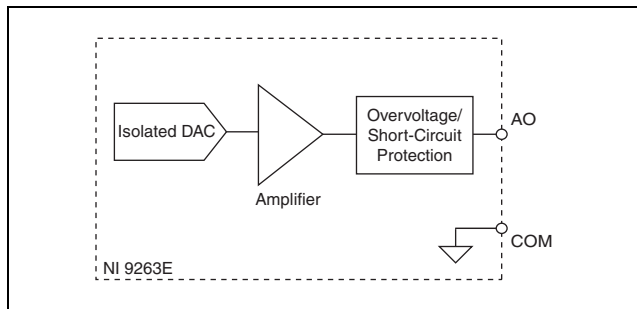


**Figure 3.** Connecting a Load to the NI 9263E

Each channel of the NI 9263E has an AO terminal and a common terminal, COM, and there is an additional COM terminal at the bottom of the connector. All of the COM terminals are internally connected to the isolated ground reference of the module. You can connect a load to each channel of the NI 9263E. Connect the positive lead of the load to the AO terminal, and the ground of the load to the corresponding COM terminal. Refer to Figure 3 for an illustration of connecting a load to the NI 9263E.

**Note** You must use 2-wire ferrules to create a secure connection when connecting more than one wire to a single terminal on the NI 9263E.

Each channel has a digital-to-analog converter (DAC) that produces a voltage signal. Each channel also has overvoltage and short-circuit protection. Refer to the [Specifications](#) section for more information about the overvoltage and short-circuit protection. Refer to Figure 4 for an illustration of the output circuitry for one channel of the NI 9263E.

When the module powers on, the channels output the startup voltage. Refer to the [Specifications](#) section for more information about startup voltage. Refer to the software help for information

## Sleep Mode

---

This module supports a low-power sleep mode. Support for sleep mode at the system level depends on the chassis that the module is plugged into. Refer to the chassis manual for information about support for sleep mode. If the chassis supports sleep mode, refer to the software help for information about enabling sleep mode. Typically, when a system is in sleep mode, you cannot communicate with the modules. In sleep mode, the system consumes minimal power and may dissipate less heat than it does in normal mode. Refer to the *Specifications* section for more information about power consumption and thermal dissipation.

<sup>1</sup> When the module powers on, a glitch occurs for  $20\text{ }\mu\text{s}$  peaking at  $-1.5\text{ V}$ .

<sup>2</sup> The power-down voltage peaks at  $1.8\text{ V}$  before exponentially discharging to  $0\text{ V}$  in  $100\text{ }\mu\text{s}$ . You can add a  $10\text{ k}\Omega$  load to reduce the peak voltage.

## Physical Characteristics

Use a dry, low-velocity stream of air to clean the module. If needed, use a soft-bristle brush for cleaning around components.

## Safety

### Isolation Voltages

Connect only voltages that are within the following limits.

Channel-to-channel..... None

Channel-to-earth ground

Continuous .....	250 V <sub>rms</sub> , Measurement Category II, (Double insulation)
Withstand.....	2,300 V <sub>rms</sub> , verified by a 5 s dielectric withstand test

Measurement Category II is for measurements performed on circuits directly connected to the electrical distribution system. This category refers to local-level electrical distribution, such as that provided by a standard wall outlet, for example, 115 V for U.S. or 230 V for Europe.



**Caution** Do *not* connect the NI 9263E to signals or use for measurements within Measurement Categories III or IV.
